TERMS AND CONDITIONS

A. The Responsibility and Duty of the Registered Company

- (1) The operator who carries out the service shall possess the appropriate license issued by the Government or have equivalent qualifications.

- (6) The registered company shall notify this society immediately of any alterations of the condition at the time of the approval, including changes of staff and of any entries on this certificate.

B. Confidentiality

The detail information acquired during the job shall not be disclosed or released to third party without permission of the applicant or this Society.

C. Scope and Limitation

The extent of engagement is limited to the scope stated on this Certificate unless attached otherwise.

D. Renewal of the Approval

E. Cancellation of Approval
